The **MSRGN 2019 Genetics Summit** is designed for a broad based audience who share an interest in genetics. The program has been developed with four primary focus areas. These four primary focus areas include: 1) newborn screening and the direct interaction between state laboratories, consumers, and lawmakers to improve outcomes; 2) public health genomics and population genomics; 3) consumer engagement and outreach to underserved populations, and 4) emerging genetic and therapeutic technologies.
