



MSRGN's TIME 4 GENETIC

Partnership Agreement 2020-2021

Section 1: Overview

CLINIC is hereby engaged as a "Time 4 Genetics Partner" to Mountain States Regional Network (MSRGN) through Texas Health Institute. A "Time 4 Genetics Partner" works with MSRGN to be educated, empowered and equipped in primary care genetics through this initiative, stemming from HRSA cooperative agreement UH7MC30776 entitled "Mountain States Regional Genetics Network."

As a Partner, **CLINIC** will access free resources, education, and training through MSRGN's 40 Clinic Initiative: Time 4 Genetics, a free program aimed at improving access to genetics services for families through primary care education and empowerment.

Section 2: Time 4 Genetics Partner Activities

The following activities are included within the scope of the Partnership Agreement:

- Time 4 Genetics Partners will access resources, training, and education through these 4-month genetic topic distribution channels:
 - Electronic Newsletter (month #1 of topic)
 - Webinars (month #2 of topic)
 - Mailable materials (month #3 of topic)
 - Family Perspectives (month #4 of topic)
- Time 4 Genetics Partners will provide data for purposes of the MSRGN evaluation. Data include details on patients served that can be reported in individual or aggregate form (clinic staff will work with the MSRGN evaluator to determine documentation approach and data sharing logistics), and completion of qualitative surveys no more than four times for year to provide feedback on program delivery and materials);
- Time 4 Genetics Partners will provide a practice point person for contact about all activities.

Section 3: Benefits of Partnering with MSRGN's Time 4 Genetics Initiative

In appreciation of the partnership, MSRGN may provide the following:

- Access to a free, genetic resources that families in your clinic can use;
- Opportunities to attend annual regional genetics meetings that MSRGN convenes;
- An opportunity to work closely and collaboratively with our MSRGN state team for your state.
- Additional technical assistance and connections with genetic professionals in your state.
- Access to comprehensive, deidentified cross-clinic evaluation data and outcome on the effectiveness of the Time 4 Genetics program (across our 8-state region); and
- Opportunities to grow your clinic through access to additional genetics education channels.

Section 4: Compensation

There is no cost or compensation associated with becoming a Time 4 Genetics Partner in the Mountain States Regional Genetics Network. If additional activities or ideas develop, MSRGN and Time 4 Genetics Partners will create additional agreements addressing cost.

Section 5: Liability

Neither party is liable to the other for the above activities or damages associated with them.

Section 6: Termination

Either party may terminate the Partnership Agreement at any time for any reason with written notice to the other party.
